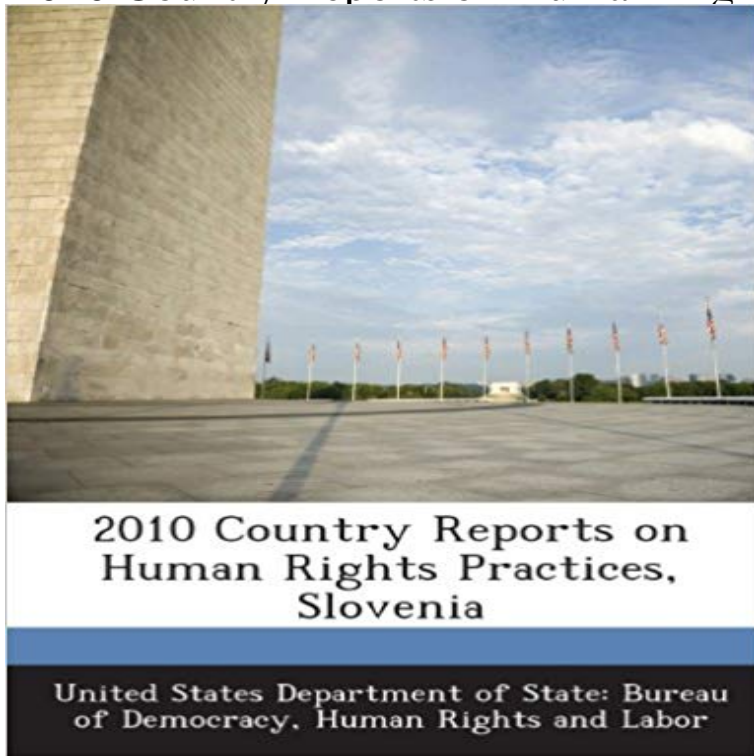


## 2010 Country Reports on Human Rights Practices, Slovenia
