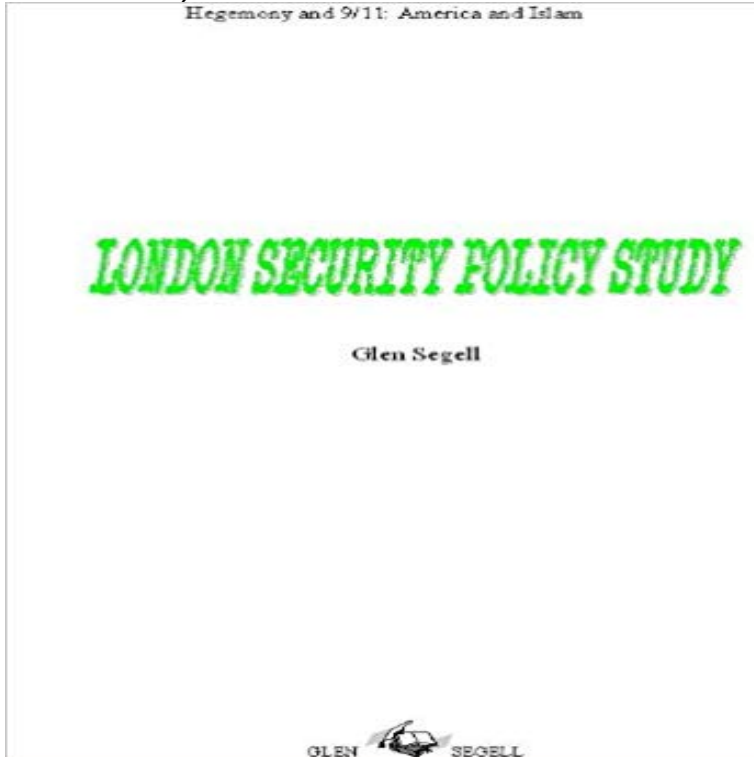


# Hegemony and 9/11: America and Islam (London Security Policy Study Book 26)



Understanding the 9/11 attacks lie not in politics and military affairs but in society. The individual is greater than the state, where expression of individuality needs to be taken within sociological context. This was the rise and decline of Islamic hegemony. The event was an expression of anger and rage by a small group, influenced by Wahabbism, perpetuating the dignity of Man through the joys and dignity of fundamentalism and heroic masculinity. The systemic theory of Robert Keohane building upon C W Mills social-historical contexts, in conjunction with the Frankfurt School, sharing Karl Marx's theory of Historical Materialism, provides the rationale for an evaluation of the context; looking at social realities, historical movements, cultural production, political economy, religion and warriors of Islam.
