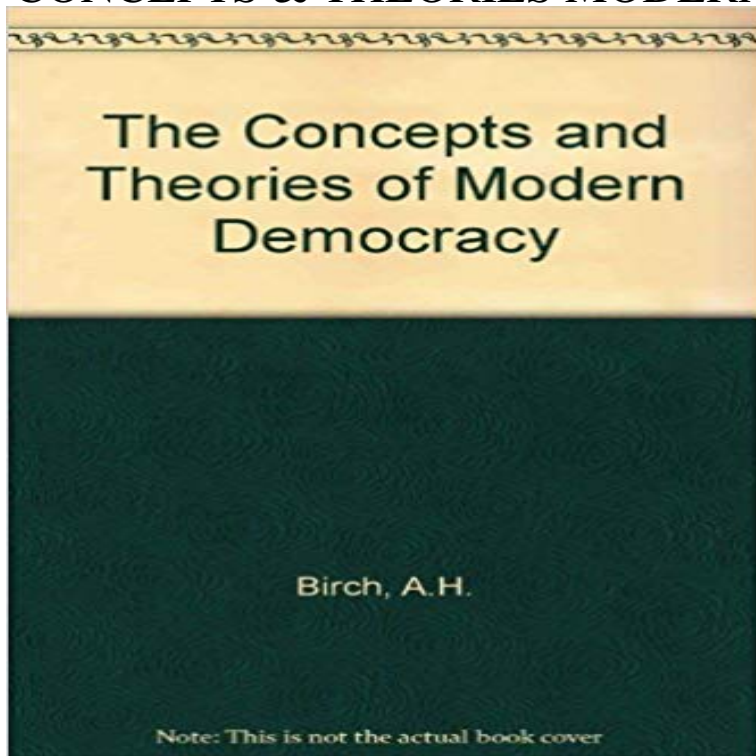


CONCEPTS & THEORIES MODERN CL
