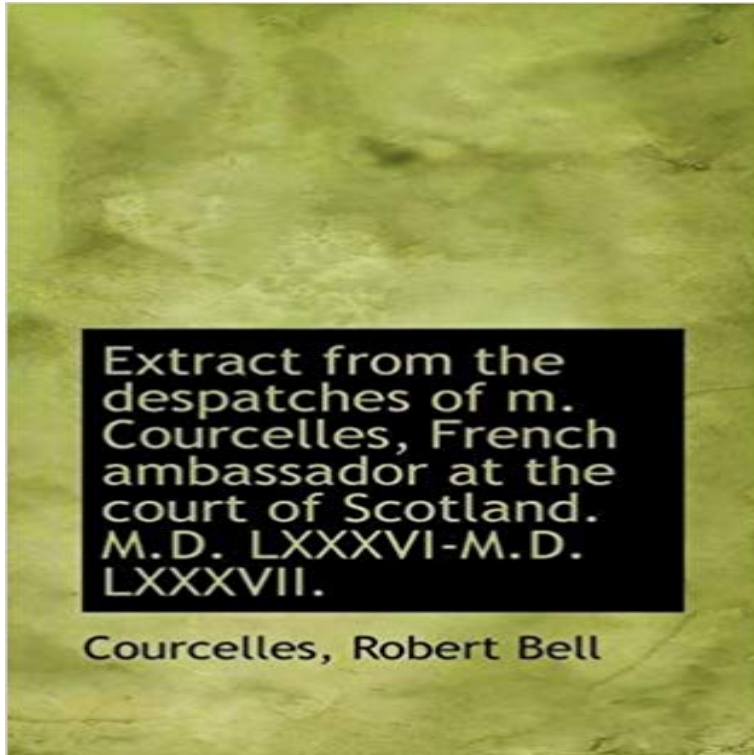


Extract from the despatches of m. Courcelles, French ambassador at the court of Scotland. M.D. LXXXV
